This time, she was thrown to ...SF Jail, when cruel & mindless SF General Hospital's staff had called ...security, since she was unable to get off her hospital bed ...fast enough. The stress of this major emotional trauma was hard enough to tolerate... Yet in addition, when she was finally released from Jail, Peace(!) Officers & med. staff RUDELY REFUSED TO RETURN HER DRESS, symbolic of Women's Hearts advocacy. Only after she called SF Sheriff-in-Chief Mirkarimi staff for investigation, the dress was "found" weeks later.

(Notably, sheriffs & med. staff felt "excused" for their uncommon lack of empathy & prejudice, due to false Arrest Warrant, due to earlier bogus Arrest, instigated in retaliation by the corrupt Berkeley City administration staff & resulting from misleading Alameda Co. Court actions. Officer Bjeldanes, responsible for these false (& absurd) criminal charges of ...water-spraying (with no investigation, instead of protecting her from the vandalism of her house) is to be "retired" finally. But, the Court charges continue to cause much stress, & are YET to be dropped by the "public servants", deliberately taking advantage of her disability by posing constant LIFE-THREATS, issued in cruel retaliation to her whistle-blower calls for public records re. misappropriation of large public funds & many legal violations. We call again upon the good will & conscience of Berkeley Mayor Bates to show his leadership & VOLUNTARILY bring it up to the high ethical standards, enacting IMMEDIATELY & WITH NO MORE DELAY his personal private apology to Ms. Gutman. Stop malicious prosecution: DROP NOW! false, disproportionate, causing LIFE-THREATENING STRESS Court charges, following similar good will example of SF Law Enforcement.)
